- Crating in vehicles only.
- Participants are responsible for keeping dogs safe and comfortable in vehicles.
- There will be no resets offered at any level.
- Qualifying ribbons and title rosettes will be offered. Including special ACE and ACEx2.

Notice to Exhibitors

Competitors, through submission of entry, acknowledge that they are knowledgeable of C-WAGS rules and regulations including but not limited to the following rules regarding entry.

All exhibitors are expected to treat the judges, trial hosts, your canine partner and all other exhibitors with respect. All judges and trial hosts are expected to show respect to all exhibitors.

This trial is open to all dogs registered with C-WAGS.

Entries of nonregistered dogs will be accepted as **FOR EXHIBITION/ENJOYMENT ONLY** ("FEO").

Teams may be entered in multiple levels/classes at the same trial.

Dogs must be shown by a member of the owner's immediate family.

Collars: The dog must wear a flat type collar (buckle, snap or proper fit martingale) and/or body harness in the ring. Electronic training collars and prong/pinch collars are not allowed on the show grounds.

Owners with disabilities are encouraged to compete. Any necessary modifications to the exercises must be provided by the handler to the judge and approved by the judge.

Safety shall always be of foremost consideration in actions and conduct by handlers at all times.

Handlers, through entry at the event, accept full responsibility for themselves and the actions of their dogs.

In addition, the organizing committee may refuse any entry for any reason.

THERE SHALL BE NO REFUND for entries in the event a dog and/or handler is dismissed from competition, regardless of reason for such dismissal.

Registration shall be completed online. Payment of entry fees and service charges shall be made by e-transfer after entry has been approved. Any fees not received within **72 hours** of notice result in cancellation of entry/entries.

Refunds will not be offered to entrants that withdraw unless the spot is able to be filled from the waitlist. Changes to your entry may incur a \$10 administration fee.

Move-ups will not be offered on the trial day.

All competitors through entry at this event waive any and all rights relative to video broadcast of this event. Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes.

Dogs must be on leash while on the show grounds unless being shown.

This event is open to dogs that may be reactive to other dogs. As such, participants are asked to maintain a minimum of 10 feet between dogs at all times (much greater space is encouraged). There is no dog-to-dog contact permitted on show grounds, excluding dogs from the same household.

Dogs with a history of aggression are not eligible to enter. Dogs that show aggressive behaviour may be dismissed from show grounds.
