Ensure you have your C-WAGS number ready to enter on the trial entry form. Also be ready to disclose the title(s) you may be eligible for at this trial based on your entry.

CALL FOR VOLUNTEERS

Volunteers are needed to ensure the trial runs smoothly. Teams may volunteer for classes they are running in and if there are not enough volunteers who are *not running* then those handlers will be assigned a volunteer role after their runs.

An incentive for *guaranteed* entry will be offered at this trial for those volunteering for classes they are not entering. Note that this offer is limited to the number of volunteer roles needed. Volunteers will be notified at least 24 hours prior to the entry opening time if they have been assigned and will be granted guaranteed entry. *To receive their guaranteed entries volunteers must fill out the trial entry form prior to the entries opening to the public.*

NOTICE TO EXHIBITORS

Competitors, through submission of entry, acknowledge that they are knowledgeable of C-WAGS rules and regulations including but not limited to the following rules regarding entry:

All exhibitors are expected to treat the judges, trial hosts, their canine partner, and all other exhibitors with respect. All judges and trial hosts are expected to show respect to all exhibitors.

This trial is open to all dogs registered with C-WAGS. Entries of non-registered dogs will be accepted as FOR EXHIBITION/ENJOYMENT ONLY ("FEO").

Teams may be entered in multiple levels/classes at the same trial.

Dogs must be handled by a member of the owner's immediate family.

Collars: The dog must wear a flat type collar (eg. buckle/snap) and/or body harness in the ring. *Electronic training collars and prong/pinch collars are not allowed on the show grounds.*

Owners with disabilities are encouraged to compete. Any necessary modifications to the search area must be provided by the handler to the judge and approved by the judge.

Safety shall always be of foremost consideration in actions and conduct by handlers at all times.

Handlers, through entry at the event, accept full responsibility for themselves and the actions of their dogs.

The trial host/organizing committee may refuse any entry for any reason.

THERE SHALL BE NO REFUND for entries in the event a dog and/or handler is dismissed from the trial, regardless of reason for such dismissal.

Registration shall be completed online. Payment of entry fees shall be made by e-transfer after entry has been approved. Any fees not received within 48 hours of notice will result in cancellation of entry/entries.

Refunds will NOT be offered to entrants that withdraw unless their spot is able to be filled from the waitlist. Changes to your entry, including withdrawal, will incur a \$10 administration fee.

Move-ups will not be offered on the trial day.

All competitors through entry at this event waive any and all rights relative to video broadcast of this event. Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes.

Dogs must be on leash while on the show grounds unless in the ring.

Dogs must remain inside their vehicle at all times unless they are being toileted, staging, searching, or on their way to or from the aforementioned activities.

This event is open to dogs that may be reactive to other dogs. As such, participants are asked to maintain a minimum of 15 feet between dogs at all times (much greater space is encouraged).

There is no dog-to-dog contact permitted on show grounds, excluding dogs from the same household.

Dogs with a history of aggression are not eligible to enter. Dogs that show aggressive behaviour may be dismissed from show grounds.
