

Available Exercises

All Working Class Exercises, except Directed Jumping (DJ/W4), will be available. Teams may adjust their chosen exercises on the day, prior to the round start.

All levels will be offered (Rookie, Elite, Expert). Move Ups are permitted.



Indoors. Rubber Flooring.

Perimeter will be the walls of the room.



Materials for Boxes and Lines

Lines will be marked on the rubber flooring with tape.

Dog boxes will be constructed from PVC. Handler Boxes will be taped.



An officiating Judge, and/or the Chairperson of the trial, may dismiss from the trial site any person subjecting the Judge or members or the organizing committee to abuse, whether that person is competing in the trial or not.



The trial host retains the right to refuse any entry for any reason. Refunds will not be issued except for medical reasons. A \$15 administration fee will be retained.
